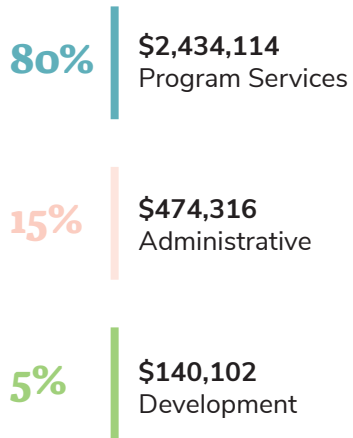
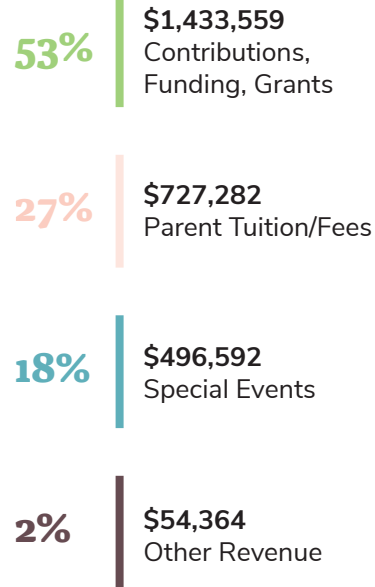

Today, Magnolia Speech School continues its legacy of excellence by incorporating evidence-based research and the latest technology to help our students succeed. Our new state-of-the-art campus in Madison, MS provides the ideal setting for this specialized instruction. We are proud to be a part of the OPTION Schools network worldwide, providing quality listening and spoken language instruction for children who are Deaf or Hard of Hearing . Additionally, we are pioneers in incorporating sensory integration techniques in our classrooms and throughout our school.

The Magnolia Speech School Curriculum is the cornerstone of our instruction, delivered by dedicated teachers and support staff in small groups and individual therapy sessions. We are committed to providing our students and their families with the tools they need to thrive in traditional education settings upon graduation from Magnolia Speech School.

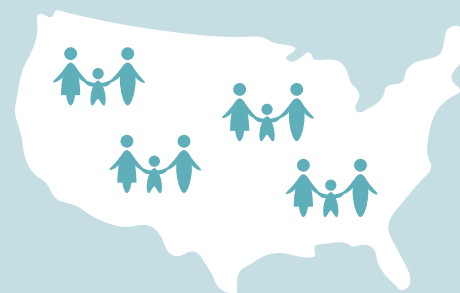
